## **SAFE HANDLING of PLATE CLAMP**

- ROPE CLAMP should always be used for intended applications
- ROPE CLAMP should always be stored indoors, never leave them exposed to the elements
- Before use, the clamp should be inspected for damage by the person responsible for it in accordance with the applicable standards.
- In clamps where damage is found, such as cracks or wear on the welded section, immediately stop using them regardless of the apparent size or extent of the damage
- Clamps which you have stopped using for safety reasons should be clearly marked as defective and stored separately
- They should never be left in the work area
- Be sure to record inspections in the log every time they are performed
